#### TERMS & CONDITIONS FOR ENGAGEMENT OF FIREMEN TRAINEE FOR 11 MONTHS

- An Agreement will be executed between the Trainee and the DPT for undergoing Training Period which will be for duration of 11 months from the date of joining the training. However, the Trainee will be required to submit latest Medical Fitness Certificate issued by the Government Hospital before appearing in the Endurance Test.
- 2. The trainee will be paid stipend of Rs.17,000/- (Rupees Seventeen Thousand Only) Per Month during the training period.
- 3. The necessary uniform and safety shoes will have to be arranged by the individual at his own cost and DPT will not make any reimbursement.
- 4. The Trainee will not be entitled to / eligible for any other allowances or financial benefits during the training period.
- 5. The trainee shall carry out the functions/duties assigned to him from time to time by the Superior Officers of the Deendayal Port Trust.
- 6. The service of trainee shall be made use anywhere in the best manner, as the Administration, DPT considers it as essential.
- 7. The Trainee shall be entitled for reimbursement of Second Sleeper railway fare or bus fare as per actual during the training period, in case of journeys performed for Deendayal Port Trust official work.
- 8. The Trainee will be entitled to the reimbursement of the boarding and lodging expenses as per actual or Rs.500/- per day, whichever is less for performing duty for and on behalf of Deendayal Port Trust at outstations.
- 9. The Trainee will not be entitled / eligible for any type of leave during the training period, except the holidays applicable to Deendayal Port Trust. A Weekly Rest would be given to the Trainee. Compensatory Off will be given in case the duty is performed on holidays OR weekly rest.
